## WAIVER AND RELEASE OF LIABILITY

**In consideration of being allowed to participate in anyway** in the St. John's Episcopal Church basketball program, related events and activities, the undersigned acknowledges, understands and agrees that:

- 1) The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment and personal discipline may reduce this risk, the risk of serious injury does exist; and,
- 2) I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THESE RELEASEES or others, and assume full responsibility for my participation, or if I am an adult signing for my child or ward, the participation of my child or ward; and,
- 3) I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and
- 4) I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS St. John's Episcopal Church and the Episcopal Diocese of Upper South Carolina their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and leasers of the premises used to conduct the event ("RELEASEES"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, OR LOSS OR DAMAGE TO PERSON OR PROPERTY, WHEATHER ARISING FROM THE NEGLIGENCE OF THE RELEASES OR OTHERWISE.
